## INTRODUCTION

Bruton Knowles are delighted to have received kind instructions to offer for sale by Informal Tender approx. 11.23 acres of pastureland near Orleton, Herefordshire in one lot.

## DESCRIPTION

Extending to approx. 11.23 acres, the land is level and has previously been both arable and grassland. The land is presently laid to pasture, having been grazed with sheep. The land is bisected by a small ditch, leaving a larger parcel of 8.2 acres of legume rich grassland, and a further 3 acre parcel of land with various trees interspersed. The land is classified as of Grade 3 on the English Land Classification.

## FIELD BOUNDARIES

A railway defines the Eastern boundary of the land which is securely fenced – this must be crossed for access to the land but there is existing gated access. The rest of the fields are bounded by a mixture of mature hedgerows and trees and livestock fencing. Any purchaser(s) shall be deemed to have full knowledge of all boundaries and neither the Vendor nor the Vendor's Agents will be responsible for defining the boundaries or ownership thereof.

## ACCESS

The sole access to the land is by crossing the aforementioned railway via double gates. This can be accessed through Inchmoor Farm. The land is to be sold with a light vehicle access right over Tunnel Lane and through the farmyard along the route marked blue on the attached plan. Please note, access is only available by crossing the railway line. The amount of access and the route can be discussed and requirements detailed on the tender form.

## SERVICES

The land is sold without a water connection. The land has previously benefitted from a private water supply which could be reconnected by negotiation. Should this be negotiated, Vendor reserves the right to submeter the purchaser's water usage and charge at a standard water rate.

## LOCATION & DIRECTIONS

The land is situated between the village of Ashton and the larger village of Orleton, via Tunnel Lane. When leaving Leominster on the A49 towards Ludlow, continue for approx. 3.7 miles from the northern roundabout and take the second left after Berrington Hall on a right-hand bend. Continue on Tunnel Lane for 1.3 miles with Inchmoor Farm track on left-hand-side (if you cross the railway you've gone too far).




### Land Plan
