The property sits on an end unit in a terrace of four. Internally, a full mezzanine level has been installed with suspended ceiling and raised flooring to provide office space with kitchen, 2 meeting rooms and a server room. The first floor also benefits from air conditioning.

The ground floor has a roller shutter door providing loading access, however at present in can only be utilised below the mezzanine. Working height is 2.44m. Further ground floor benefits include; 2 fire escapes, gents and ladies WC, ample electricity points, kitchen and Veritas fire alarm system.

The unit benefits from a steel portal frame construction with fluorescent strip lights and 3 dedicated parking spaces to the front.

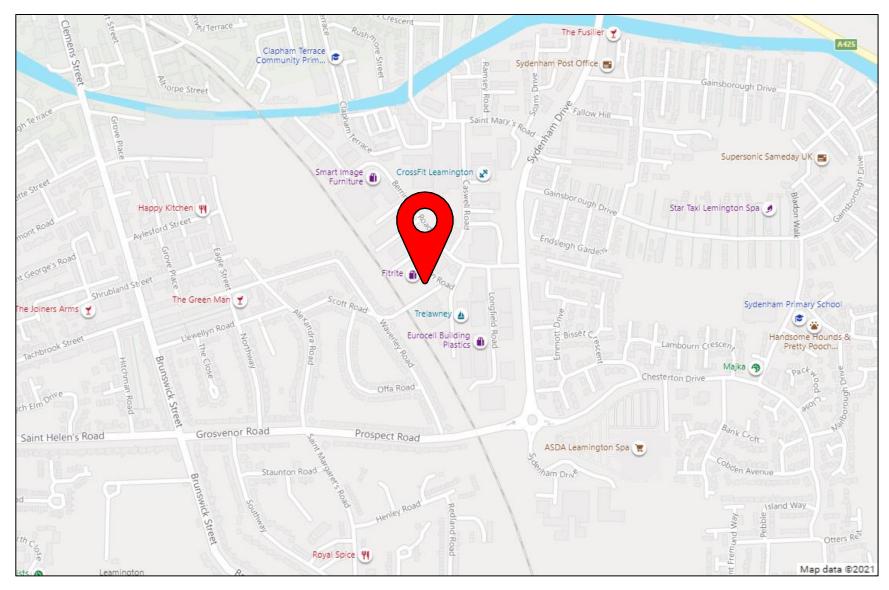
