LOCATION

The land off Berkeley Road is located adjacent to the M5 motorway at the bottom of Taits Hill and east of the junction of the A38 Gloucester to Bristol trunk road and the B4066 Berkeley Road, in the county of Gloucestershire. The land is accessed direct from the B4066 Berkeley Road. Gloucester, Cheltenham and Bristol are all within easy reach and the M5 J14 is approximately 5 miles south.

DESCRIPTION

The land is in one block and is currently in arable cropping. The land is divided into two field parcels and is bound by mature hedges and woodland. The land is accessed direct from the B4066 via an agricultural entrance.

There is a right of way over a track leading around the edge of the sourthern parcel which provides access to the northern parcel so the land could be sold in two lots and parties are invited to offer on either parcel or as a whole.

TENURE

The land is occupied under a Farm Business Tenancy until the end of September 2021. The land will then be available freehold with vacant possession upon completion.

SERVICES

We are advised that mains water is nearby but not currently connected. There is also a high volatage power cable crossing the property.


