## LOCATION

Lydney Harbour Estate is located in Lydney a town and civil parish in Gloucestershire, England. It is located on the West Bank of the River Severn in the forest of Dean District and is approximately 16 miles southwest of Gloucester. The industrial estate is located on the South East side of Lydney and accessible via the A38. Junction 16 of the M5 is approximately 30 mins drive. Gloucester and Bristol are within a 1-hour drive.

## DESCRIPTION

The industrial estate provides a mixture of industrial units of both of steel portal and truss frame construction and a mixture of brick block and clad elevations. Roller shutter access is provided to all units.
