### Location & Description

The property is located in a busy residential area within a small parade in this popular coastal town. The town centre is approximately two miles away. The property is next door to a barbers and other occupiers in the Parade include, Co-Operative Food (convenience store), Headlines (hairdresser) and Pyramid Health (chiropractors).

This double fronted prominent shop offers sizable retail and storage accommodation in a busy Parade in Exmouth. The property is presented in good condition with a partial suspended ceiling, strip lighting and spotlights, kitchenette, raised display area (in Unit 1), a security alarm and an electric heater over the entrance of Unit 2. There is useful rear storage, as well as an enclosed yard for further storage and parking. There is also an old storage container (1.97m wide by 4.2m deep) within the rear yard.

The Parade provides a large number of free customer parking spaces to the front of the retail units, as well as a rear service yard for deliveries and parking for the occupiers.

The premises were previously used for the sale of mobility scooters but would suit a variety of other retail, office or consulting room uses.


