## LOCATION

The site is located on the northern edge of the town of Hartlebury, Worcestershire. The A449 runs along the eastern edge of the site linking the village directly to Kidderminster (c.4.5 miles) to the north and Worcester, (c.11 miles) to the south. Hartlebury benefits from a primary, special needs school, public houses, castle tourist attraction and trading estate providing employment opportunities. The site is well connected via road and there is also a railway station in Hartlebury which offers regular services to Stourbridge, Worcester, Stratford-upon-Avon and Birmingham.

Access to the site is provided in the south western corner via an established agricultural gateway off Rectory Lane.

## DESCRIPTION

The site extends to approximately 19.67 acres (7.96 hectares) and comprises arable land with a small area of trees and scrubland at the most northern part of the site. The site sits between the B4193 to the west and the A449 to the east. To the south east of the site are a number of allotments owned by the Church Commissioners for England.

The site forms part of the wider Freehold Title WR144670.

The remainder of the Title is shaded in blue on the front page which includes c.82.78 acres (33.51 ha) to the west of the B4193 and c.5.85 acres (2.37 ha) to the east of the A449.

## PLANNING

The site lies within the planning jurisdiction of Wychavon District Council. Planning Policy is covered by the South Worcestershire Development Plan (SWDP). The plan is currently undergoing review. The south Worcestershire Councils have formally submitted the South Worcestershire Development Plan Review (SWDPR) and associated evidence base documents to the Secretary of State for independent examination.

The site is located within the Birmingham Green Belt, however is not located in a conservation area or Area of Outstanding Natural Beauty (AONB).

It is understood that the parcels of land to the south of the site registered under Freehold Titles WR176492 and WR189722 are actively under promotion.

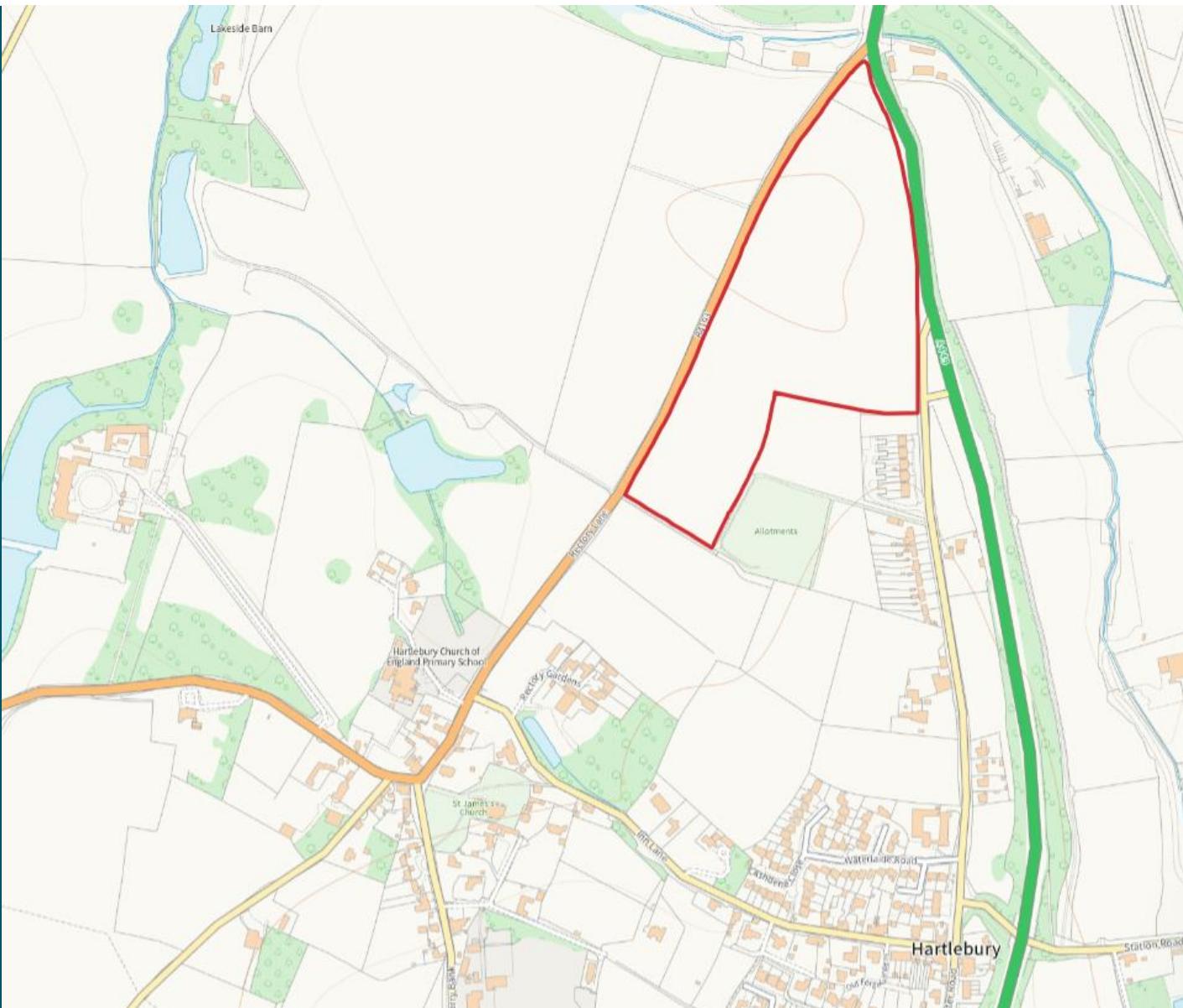
